### Meeting called to order at **1803** hours

#### Meeting suspended for presentation by Massachusetts State Police Airwing

Trooper Spencer gave informational report on capabilities of airwing. Currently have four air units. In the event that a chief wishes to request the services of the airwing for water drops at a wildland fire a request must go through your district fire warden. Reminded the group that it can take a while to get water to scene based upon availability and where they are responding from. Also they like to burn some fuel prior to picking up water. They also prefer to have the Chief or designee do a fly over of the incident to get a full picture of the incident. Chopper can carry 84 gallons of water

If utilizing airwing for search and rescue they suggest that groups of rescuers are better and easier for them to provide information and direction to victims. They also prefer to communicate with an established command post as they have numerous radios that they are monitoring so the less air traffic they need to listen to the better. Best case scenario for them is to have a Trooper on the ground responding to the command post and all info relayed from incident commander to chopper via trooper. If the incident occurs on DCR property it is critical to contact DCR/Lt. Peter Michaels as he has detailed mapping available for use. The Troopers also recommended the use of handheld GPS units and to follow the directions of the airwing.

If any Chief's have requests or if you have something you feel that might be useful at an incident involving the airwing please feel free to reach out. Trooper Spencer provided a contact # of 413-378-1200 or you can request assistance the Northampton Barracks.

They are currently working on and testing a web based view which would allow a chief to sign into a password protected web site in order to have an air view of what the chopper is seeing. Also stated that if landing in community they request a 100'X100' area just like Life Flight.
