Taught at NH Fire Academy. Hazmat Specialist on USAR team in Beverly. Spoke about training programs at MFA and some of the challenges and limited resources. Spoke about opening Springfield campus and running a recruit class in Springfield this fall, specifically early October. Will graduate the Thursday before Christmas. Construction still ongoing at this location. MFA working on bringing on new Instructors for this facility and teaching this recruit training program. Right now there are over 300 programs and teach about 13,000 students across the state. Trying to balance the training across the state.
